What do foster carers value?

- Emotional and practical support from their SSW and fostering service
- Being trusted, respected and valued
- Reliable, available SSWs, particularly at times of crisis, or stress
- Levels of contact with SSWs
- Home visits and telephone contact
- Support around problematic contact
- Respite
- Manageable SSWs workloads

How can SSWs enable foster carers to be active members of the 'team around the child'?

- Involvement in decision making and planning
- Foster carers within the professional network
- Trust, respect and being valued by SSWs
- Effective interpersonal communication
- Sharing information
- SSWs knowing the foster child
- Help managing troubled behaviour
- Joint training

Additional findings from the literature review

- Foster carers' views regarding SSWs and foster children's social workers
- Relationships between SSWs and foster children's social workers
- Placement disruptions and support
- Supervision of SSWs
- Independent fostering services and public fostering services
- Retention of foster carers linked to the quality and quantity of the support
- Social work education and training

Recommendations for policy, practice and research

- SSW caseload management to ensure effective direct work with foster carers
- Supervision of SSWs to enhance their role
- Practice guidance on the SSW role
- The SSW and the personal and professional development of foster carers
- Enhancing the relationships between SSWs, foster children's social workers and foster carers
- Social work education and training to include foster care knowledge and skills
- Research about effective SSW practice
